REPORTS & COMMUNICATIONS FROM THE MAYOR/SAFETY DIRECTOR

Nik Janek, Liaison with Lake County Health Board, reported the Lake County General Health District discontinued the school nursing program. (See summary report attached).

Mayor congratulated Patrolman Slapnicker as he was awarded the State D.A.R.E. Officer of the Year. Proclamation at next meeting.

Senior Center Open House next Wednesday, June 26, from 2pm-6pm.

Willowick will be hosting the Independence Day fire works with Eastlake and Wickliffe on July 3 at Captain's Stadium.

Due to the extreme heat, there were discussions for a possible cooling center at the Community Center, as there has not been a need to date. The situation will continue to be monitored.

Mayor thanked the Rec and Service Departments for getting the pools ready.

The road program is near completion with Barjode being rapped up today in the next couple of days. Vine Street completed on the Willowick end and looks great.

Civil Service did not have enough applicants for the position of Assistant Fire Chief so meeting next Tuesday to move forward.

Later in the meeting, Mayor asked if there could be a Finance Committee Meeting at 6:30 on July 16 to discuss financing for the fire department staffing. Councilwoman Bisbee approved request.

Director Kless reported all programs are going well with counselors and lifeguards doing a great job.

The pool dedication for Martin Guzauskas will be held on July 21 at 11:00am.

City Engineer - Tim McLaughlin

Engineer McLaughlin mentioned the demolition of the house next door is under contract and is within the timeframe to complete the job.

He discussed the add-on placed on the agenda for consideration regarding the community center generator project.

The E. 305th sewer project plans are complete and additional funds are being applied for from the county. Bids expected to go out in July.

Councilman Phares asked what kind of project is the E. 305th plan. Engineer McLaughlin explained it is a rehabilitation project from Willowick Drive to Lakeshore Boulevard. The storm sewer portion is mostly to remove calcification and the sanitary sewer is partial replacement, partial cement realigning and replacement of the laterals in the right of way.

Finance Director - Cheryl Benedict

Director Benedict noted the motion for the 48-month lease for the multifunctional devices throughout the city and the resolution for new radios for the police department that have been budgeted with \$60,000.00 of the local fiscal state recovery funds for down payment. Remaining balance will be financed with Huntington at an interest rate of 5.10% for five years.

Councilwoman Bisbee inquired about the \$6,697.00 from Ohio Business Machines, which Director Benedict explained will pay off the copier lease with the current provider.

Tax Budget Hearing held at 8:15 by Finance Director

Director Benedict reported that the tax budget was prepared for all funds receiving property tax revenue and it recertifies to the County Budget Commission the millage the City is allowed to assess under the current legislation justifying the need for it. The millage request is 19.75 mills and it reflects no change from the total millage currently being assessed. (The tax budget legislation under **Resolution 2024-33** received votes and approval following the finance director's report. See *Introduction of Legislation* section).
