REPORTS & COMMUNICATIONS FROM THE MAYOR/SAFETY DIRECTOR

Mayor Vanni reports that since we have last met, there have been two major weather events. He thanks police, fire, service for all their work during these storms. The first storm was right before Thanksgiving on the 21st and we had more down tree branches than we did from the tornado breakthrough in August. He did not realize the damage until walking through the City the next morning. We couldn't get all the way through it before this big snow storm this past weekend. They are still digging out but have done a great job keeping roads clear. Getting to what they can. Leaf pickup was supposed to go to the 6th but cannot see leaves anymore. Weather should warm up next week, but it depends what hits tomorrow since we are looking at another big storm. Everyone should have gotten a letter from Major Waste explaining how the switch will take place. They have been getting calls at City Hall. Some were making sure this was not a scam. He posted his article from October on the Facebook page and added some additional information. If you did not get that letter, please have them reach out to Major Waste if they have questions. There are 3 ways to sign up for service, it is pretty easy. Lastly, we are in Christmas season. A resident reached out, who was actually his neighbor like 16-17 years ago. He rents Dudley out; he owns Encore Limousine. Monday December 9 from 5-9 they are having a Christmas party for all the needy families. Names came through WE School System. He is donating his limo bus and taking people downtown to see the lights as well. Santa will be there. They are asking anyone that comes to bring a Christmas gift for all the needy families. Kids range from 6 months to 18 years old. Looking for pjs, socks, underwear, hoodies, hats, gloves, etc. These families are in need of these items. Gift cards from Giant Eagle and Walmart would also be appreciated. Julie couldn't make it tonight, but December 15 from 1-5 at Manry there is Winter Wonderland.

COUNCIL DISCUSSION OF THE MAYOR'S REPORT**GENERAL COMMUNICATIONS & REPORTS – Directors & Officials****Service Director – Todd Shannon**

Service Director Shannon: They have been picking up branches and plowing snow. It's been a long two weeks and they are doing the best they can. There are only so many resources to pick up branches and people are literally putting out full trees. Snow came through and guys did a great job. More snow coming tomorrow. In addition to what the Mayor said about Major, they are working on logistics for bags. Working it out with Major at the moment.

Ms. Antosh says the bags are at a cost, right? Not free?

Shannon says they are still working that out, but yes. Maybe stickers for the bag service? Working through it.

Mr. Malta says a resident reached out about not recycling. They don't want another can.

Shannon says he suggests reaching out to Major. The deal is between the resident and the company.

Mr. Malta says thank you for that as well as thank you for the tremendous job they are doing with everything right now. We are lucky to have the three of you.

Police Chief – Rob Daubenmire

Police Chief Daubenmire submitted his report electronically today. December 13 around 2:00 they will have a Christmas program to pick up 10 children and take them via limo to go Christmas shopping. There will also be police cars, this should not be a concern to residents.

Mayor Vanni says that is a great event that they put on. The kids have a great time. Thank you for doing it.

Fire Chief – Bill Malovrh

Fire Chief Malovrh has no report but wants to bring up that at next Council meeting, they will be putting forth legislation for radios. They are in a situation where the County, as a group, is buying radios and it has to be in soon. It's an opportunity to replace radios now. They may be paperweights in a couple months. He went to Mayor Vanni and explained the options. They will be putting it to Council quickly, sorry for that, but it's a chance to get a discounted price.

Ms. Bisbee says thank you for the response when the lines came down in the first storm. She appreciated the quick response.

Mayor Vanni says he wants to pick up where Chief left out. Radios are basically obsolete. They were faced with a decision last year and we were able to get \$60,000 of ARPA money for it and financed the rest. Talking to Fire Chief, they have been able to flash them and buy them some time. The issue is that we don't have the money to take care of this from Police and Fire Capital Fund. They believe the best thing to do is get the radios with the County Bulk order but maybe take it out of the General Fund. They were approached on short notice. It looks like the best way to get this done and over with is to take it out of the General Fund. It'll be ready for the next meeting. Feel free to reach out to Mayor, Chief, or Cheryl before the next meeting.

Ms. Antosh asks if there is a minimum you have to buy?

Chief says right now we have about 30. They are looking to change the way they operate. He is looking to minimize what we have in stock and assign radios per shift. You sign them out per shift which will enable them to lessen what they have from 30 to 15.
