New testing date set tentatively for the weekend of November 9 & 10 (or it was agreed another weekend that coincides with the police department schedule) pending contact with OACP coordinator. Mr. Tobin offered to contact and subsequently left a voicemail for Ms. Murphy during the meeting. (Call was not returned before meeting's end)

The Commission reviewed and discussed the previous notice and application provided from the October 22, 2022, testing period. After review and recommended changes for current testing, all agreed the applications (for <u>any</u> November test date) be available for pickup beginning Monday, October 7, 2024, to Friday, October 1 1, 2024 with submission dates of Monday, October 14, 2024 to Friday, October 1 8, 2024, between 8:00am and 4:00pm, on the second floor of City Hall.
