City Engineer's Report - Tim McLaughlin  
There was no written report submitted and no questions for the City Engineer at this time.

Law Director's Report - Ms. Bell

Remarks - New Business

Tom Larney - WAP Construction - Larimar

Tom Larney was present and explained the plan changes from the original plan which was 4 buildings consisting of 3 triplexes and 1 duplex totaling 14 units. They have had a lot of trouble selling the triplexes as nobody wants a center unit. There is a huge demand for first-floor master units like across the street at 174 & 175. It is the same building, but with a lower-level basement on the creekside. If they change them to all duplexes it will be a total of 5 buildings with a total of 10 units. They are losing 4 units, but these seem to be selling quickly. They have 4 or 5 people ready to sign that he's been holding off while he sees if they can get this approved. Mr. Carden asked if these units will look the same esthetically as the other units that are already there. Mr. Larney said they will look exactly the same.

Mr. Carden said that he had no issue. There shouldn't be any traffic issues, there should be even less traffic with fewer units.

Mr. Foisel was just reiterating that they are just replacing the triplex units with 5 duplex units. Mr. Larney stated yes.

Motion by Mr. Rising, Second by Mr. Foisel to recommend to Council the approval of Larimar's Revised Site Plan.

Michael Johnson was not present at the meeting.

Mr. Carden stated that a few boxes need to be checked by the Police Department.

There were questions regarding the number of hours with only one employee working, and the size of the space for the intended 2 occupants at a time with one being the owner and 4 seats.

Adjournment


Motion by Mr. Carden, second by Mr. Kelbach, to adjourn the meeting. Discussion: None. Vote: All ayes. Motion carried.
